Fred Owens, PhD Professor Emeritus Williamson School of Business Youngstown State University

Fred Owens has been Professor of Business and Program Head of Telecommunication Studies at Youngstown State University for the past 50 years (until his retirement in September, 2021). He has twice been named Distinguished Professor of YSU (for excellence in teaching and community service) and visiting professor by the National Academy of Television Arts and Sciences Foundation in 2007. He received the Stephan H. Coltrin Award for Excellence in Communication Education from the International Radio and Television Society Foundation and the Watson Merit Award from YSU. He served as chairman of the YSU Department of Communication from 1983 until 1998. Prior to that he held various teaching positions, and throughout his career he worked in commercial television as a producer/director. He has authored textbooks and research articles in the communication and organizational behavior fields. He was a founding advisor to the creation of Western Governors University in 1997. Fred received his PhD in organizational behavior and leadership, having studied with John Child of the Aston Business School (Manchester), a Master of Arts in Telecommunications, and a Bachelor of Arts in communication.

His teaching activities have focused on basic media courses as well as advanced television production, community leadership and organizational development. One recent development project has been Homework Express, a live TV show aimed at helping middle-and high school students learn math. Homework Express served as a community service for students, teachers and caregivers, a promotional tool for the university and its programs, and a teaching/learning vehicle for students in YSU's media courses. Homework Express has been nominated twice for the Emmy Award, and it won the national Festival of Media Arts at the National Association of Broadcasters convention in Las Vegas. He also led a faculty team to create a new Major in Sports Broadcasting and a weekly television program celebrating Youngstown's arts and entertainment corridor, Light the Wick. He served as Telecommunications Team Leader for the Ohio Board of Regents' Articulation and Transfer Advisory Council from 2010 until 2021. He has taught undergraduate and graduate courses in management, organizational design, strategic planning, corporate and public policy making, finance, interest-based bargaining, corporate media relations, and more.

He has served as impresario for audio theater productions, including the branded Good Humor Radio Hour.

Fred has participated in and supervised major strategic planning projects and communication audits. For example, he authored YSU's first Strategic Plan in 1993, supervised North Central accreditation visits, oversaw National Association of Schools of Theater accreditation, and guided the creation and implementation of "Austintown 20/20 – a community vision plan." He has consulted to media companies on their strategic planning processes. He has served on the administrative bargaining team to implement the Interest-based Bargaining Model for the YSU-OEA collective agreement. And he served as proxy board member of Western Reserve Public Media.

Fred has been active in community service. He is a board member of ASECU and a member of the Board of Supervisors of Mahoning Soil and Water Conservation District. He

has been President and Foundation board chairman of Rotary Club of Youngstown (#137, District 6650) and Division I Assistant Governor. He is a Paul Harris Fellow. He served as the president of the Austintown Growth Foundation (a community development association). He has served on corporate/community boards, including the community advisory board of the Salvation Army, the American Diabetes Association, and the Forum Health Community Board. He collaborated with the Youngstown Area Arts Council to produce Walk on Wick, and he coordinated production with the Youngstown-Warren Regional Airport, the United States Air Force, and Rotary of Youngstown two successive Youngstown Air Show events. He has raised many thousands of dollars through corporate underwriting, foundations, and individual contributions — both for YSU programs such as Homework Express and for various community projects. He has supervised and judged competitive forensics at the university and secondary levels. He was inducted to the Austintown Hall of Fame by the Austintown Growth Foundation in 2016.


